ANNUAL PUBLIC NOTICE

Additions to the Voters List and/or Personal Security Protection Requests

In accordance with Section 36 of The Municipal Councils and School Board Elections Act (MCSBEA), the Town of Niverville Voters List is open for changes or revisions.

- Any person who is eligible to vote in municipal elections in the Local Authority of the Town of Niverville can have his or her name added to the Voters List, or have any information about the voter in the Voters List corrected.
- Any person can request to have his or her name and address obscured from the Voters List.

A person whose name has been obscured will receive a Personal Security Certificate and identification number. In a vote on a question, that person may only vote by Sealed Envelope Ballot and cannot vote in person at the regular or advance voting places.

To implement the above, a written request including name and address along with proof of identity must be submitted to the Senior Election Official in person, by e-mail, fax or mail to:

Please note that the Voters List will be closed to revisions on October 21, 2019.

Non-resident property owners are not allowed to vote in the plebiscite vote.

2019 Added Property Tax bills have been mailed

For property owners that have had an assessment change to their property for changes such as a new house or building, added garage, basement finish, deck added etc., the 2019 Added Tax Bills have been mailed. These bills are due **December 31, 2019 at 5:00 p.m.**

Residents are asked to note that the **SNOW ROUTE PARKING BAN will be in effect from NOVEMBER 1, 2019 through APRIL 1, 2020**, (between the hours of **6 a.m. and 6 p.m.**). This street parking ban will be in effect following a snowfall event (Bylaw 801-18).

After a snowfall has occurred where snow clearing is required, Town Staff will begin their initial clearing operation at 5:00 a.m. and will plow around any vehicles that are parked on the streets. The following day, the Snow Route Parking Ban will be in effect between the hours of 6 a.m. and 6 p.m. and vehicles will not be permitted to park on the designated snow routes to enable Town Staff to complete snow clearing operations.

Vehicles (including trailers), that are parked on the streets identified as the designated snow route on the second day (and any subsequent days needed) when a Street Parking Ban has been implemented, will be ticketed and towed.

NOTICE OF PLEBISCITE ON THE LOCAL RETAIL SALE OF CANNABIS

Notice is hereby given that a vote of the Town of Niverville will be taken to determine whether the retail sale of cannabis will be permitted within the municipality.

Voters will be asked the following question:

Should licensed retail cannabis stores be allowed in Niverville?

- Yes, they should be allowed.
- No, they should not be allowed.

****Non-resident property owners are not entitled to vote in the plebiscite.**

VOTING PLACES

Location for voting will be at the Town Administration Office, 329 Bronstone Drive, Niverville, North East Entrance on **Tuesday, November 26, 2019** between **8:00 a.m.** and **8:00 p.m.**

IDENTIFICATION MAY BE REQUIRED BEFORE BEING ALLOWED TO VOTE. A person may be required to produce one piece of government issued photo identification (for example—driver's license or passport) or at least two other documents that provide proof of identity.

ADVANCE VOTING

For the purpose of accommodating persons who are qualified to vote, but who have reason to believe that they may be absent or otherwise unable to attend their proper voting place on Plebiscite voting day, an advance voting opportunity will be located at the Town Administration Office, 329 Bronstone Drive, Niverville, North East Entrance, and will be open on **Monday, November 18, 2019** between **8:00 a.m.** and **8:00 p.m.**

MOBILE VOTING

For the purpose of accommodating persons who are qualified to vote, but reside either in a personal care home or senior facility, a mobile voting station will be set up at the following locations on **Wednesday, November 20, 2019**.

1. Niverville Heritage Personal Care Home **9 a.m. to 11 a.m.**
2. Niverville Credit Union Manor (lobby) **1 p.m. to 3 p.m.**

APPLICATION TO VOTE BY SEALED ENVELOPE

A voter who is unable to go in person to the voting place or vote in advance, may apply in person or in writing to the Senior Election Official at Town Administration Office, 329 Bronstone Drive, Box 267, Niverville Manitoba, R0A 1E0 or by fax at (204) 388-6110.

If applying in person, a voter may apply between **October 29, 2019 and November 23, 2019**. A voter applying in person may pick up a sealed envelope ballot package at the time of application.

If applying by mail or fax, a voter may apply between **October 12, 2019 and November 23, 2019**. A voter applying by mail or fax will receive a sealed envelope ballot package by regular post, or by making alternative arrangements with the Senior Election Official.
