Personal Security Protection Requests

In accordance with Section 36 of The Municipal Councils and School Board Elections Act (MCSBEA), the Town of Niverville Voters List is open for changes or revisions.

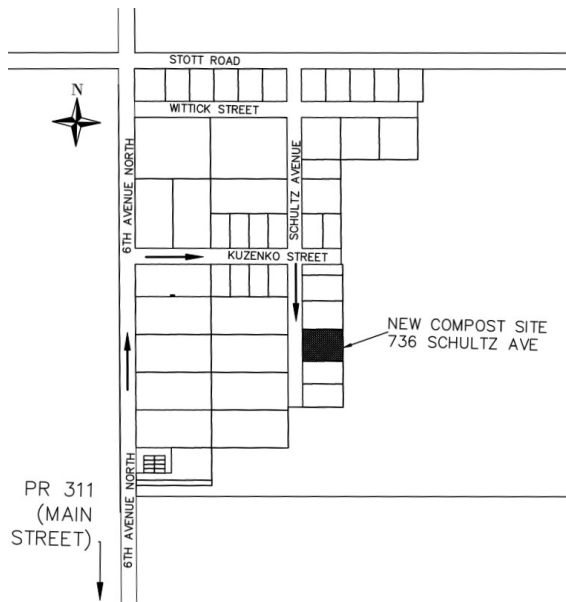
- Any person who is eligible to vote in municipal elections in the Local Authority of the Town of Niverville can have his or her name added to the Voters List, or have any information about the voter in the Voters List corrected.

- Any person can request to have his or her name and address obscured from the Voters List.

A person whose name has been obscured will receive a Personal Security Certificate and identification number. In a vote on a question, that person may only vote by Sealed Envelope Ballot and cannot vote in person at the regular or advance voting places.

To implement the above, a written request including name and address along with proof of identity must be submitted to the Senior Election Official in person, by e-mail, fax or mail to:

NEW COMPOST SITE FOR 2020

Residents are asked to note that the location for dropping off grass clippings and leaves has changed to 736 Schultz Avenue (Niverville Business Park). The compost site behind the curling rink is now permanently closed. Branches need to be brought to the local transfer station or a landfill site of your choosing—they will not be accepted at this site.

**Hours of operation will be: Monday–Friday: 2:00 pm–8:00 pm
Saturday: 10:00 am–4:00 pm
Sunday: 1:00 pm–6:00 pm**

Site will be opening in May. Please do not dump at the site until it is open. Stay tuned to www.wheretheybelong.ca for an announcement regarding the official opening date. Please note that the site is under 24 hour surveillance.

SEWER BACK UP REMINDER

Experiencing a sewer back up issue? Before you incur any costs by calling a private sewer cleaning company, please contact the Town first. Town staff will then check the sewer main to determine if that is where the problem lies. During regular office hours, call the Town Office at 204-388-4600. After hours, contact Operations at 204-388-4600 ext. 111 and leave a message including call back telephone number. Within a reasonable time frame, a staff member will call you back confirming the matter and if required, complete a site inspection. To help prevent sewer blockages in the Town's main line, please remember the following:

Kitchen grease, feminine hygiene products, Q-tips, wet wipes and similar items need to be disposed of in the weekly dry garbage removal.

Teach our children that shirts, towels, toys, etc. cannot be flushed into the sewer system.

When a sewer problem is first noticed- stop flushing and/or draining water within your home. Your sewer backup valve, if operating correctly, should prevent sewer from the main line from backing up into your home. Environmental responsibility begins at home. Thank you for your cooperation in this matter.
