Frequently asked questions

Why did I receive a separate waste levy invoice?

A waste (garbage) levy is normally included on the property tax statement. However, due to a glitch when the tax statements were printed, this amount was missed on the 2020 Property Tax statements, requiring the Town to issue a separate invoice to collect the levy.

Does the \$118.04 need to be paid separately?

No. The waste levy amount can be included with your property tax payment regardless of what payment method you use (online, banking app, cheque, etc.).

My mortgage lender pays my property taxes directly to the Town. Do they know about this amount?

Yes. Mortgage lenders have received the statements and are aware of the total property tax amount owing, which includes the waste levy.

How can I pay?

In the interest of public health and safety, the Town is encouraging residents to use contactless payment options if at all possible. Cash payments are discouraged at this time.

On September 30, 2020, the Town will have staff available outside the Administration Office between the hours of 8 am to 5 pm to accept payments so that residents do not need to get out of their vehicle or come inside the office. More details to follow on the Town website.
