Did You Know?

The Town's Traffic and Parking Bylaw 801-18 regulates things like:

Section 3.2 No person shall park a vehicle on a street in such a manner that it obstructs the entrance to a lane or to a driveway or an approach leading to a private premise or public pathway.

And

Section 3.7 No person shall park a vehicle on a street for fourteen (14) consecutive hours or more, within the Town of Niverville.

Going for a walk with your dog? Remember it is the pet owner's responsibility to pick up their pet's "treasures". Please help to keep our community clean.

Licensing of Pets

All dogs and cats over the age of six months must be licensed. Annual license fee is \$20.00 per pet, valid for 12 months from date of issue; an early renewal fee of \$15 may apply. *Please note that dogs and cats are not permitted to run at large*. In the event that an impounded dog or cat is found to be unlicensed at the time of capture, the license fee is \$100.00. The fee for first time impoundment is \$200. Proof of rabies and distemper vaccinations must be presented at the time of application before a license can be issued. Note that the breed of the dog must be documented on the vaccination papers presented for licensing. Licenses can be obtained from the Town Office, 329 Bronstone Drive.
