## Property Tax Reminder

Niverville's 2022 property tax bills have been mailed. If you have not received your bill you may request a copy. New property owners are reminded that they are responsible for the payment of the taxes whether or not they have received a tax notice in their name. If you would like to request a copy of the statement for your property or have questions regarding your property taxes, email [taxes@whereyoubelong.ca](mailto:taxes@whereyoubelong.ca) or call 204-388-4600 ext.1201.

**All tax payments must be received in the Town Office by 5 p.m. on the due date.** Cheques may be post-dated to the due date (Sept. 29, 2022) but must be received by the Town Office **on or before September 29, 2022 by 5 p.m.** or they will be considered late and will be subject to a penalty. Receipts may be emailed upon request or picked up at the Town Office.

All taxes remaining subsequently unpaid are subject by law to a penalty of 1.25% per month (compounded annually). STATEMENTS CURRENTLY SHOWING ARREARS WILL HAVE ADDITIONAL PENALTIES. Call the Town Office or log in to your eServices account for an updated balance on the day the payment will be remitted. (please allow at least 3 business days for bank processing)

- Metal
- Concrete
- Paint
- E-Waste
- Batteries
- Tires
- Oil & Oil Filters
- Propane Tanks
- Light Bulbs
- Fridges (\$20 per unit)

In conjunction with the Fall Clean-Up Day, the Niverville Credit Union will be sponsoring Community Shred Day, where residents will be given the opportunity to shred their documents for free. This will be taking place **Saturday, September 24th between 9 am and 1 pm** in the Niverville Credit Union Parking Lot, 62 Main Street.

## CONSTRUCTION UPDATES

The 2022 Road Repairs are scheduled to start in the middle of September. Larger repairs include sections of Lilac Place, 4th Street South, Hampton Drive, Cobblestone Court, Lytham Place, and asphalt path work along Drover's Run.

The Mulberry and 311 Intersection Project is ongoing and scheduled to be substantially completed at the beginning of September.



Phase 1 of the Opa's Park Revitalization Project has begun.

Landscaping restoration for the 2022 Concrete Program is ongoing.

Re-landscaping of the new dog park area will commence in September.

## SEWER CLEANING

Sewer cleaning will be taking place this year on **September 24-25, 2022**, with no specific timeline for the affected streets.

Occasionally during sewer cleaning, air pressure builds in the sewer line causing water to splash out of toilets, sinks and drains. Please take the following precautions to prevent water damage in your home:

- Close lids and cover toilet bowls when not in use.
- Insert drain plugs in all sinks and bathtubs when not in use.
- Remove all floor mats in bathrooms.
- Place an old towel around base of toilets.
- Cover all basement floor drains.



Sewer cleaning on rare occasions may leave an odor in the home. If so, please run some water down all sink and bathtub drains, flush toilets, pour a pail of water into each basement floor drain and open your windows. After a short time the odour should go away.

## VOTER'S LIST ADVISORY

Please be advised that September 20, 2022 is the last day for changes to be made to the Voter's List. In order to be eligible to vote in Niverville, you need to be a Canadian citizen, at least 18 years of age on Election Day, and a resident of Niverville for at least six months on Election Day, or a registered owner of land in the municipality on Election Day for at least six months before Election Day.
