

- That all those portions of Balgownie Street and Montrose Avenue contained within the limits of Parcels A, B, C, D, E and F on a Plan prepared by Albert Gerhard Degner, of the City of Winnipeg, Manitoba Land Surveyor and sworn to by him on the 24th day of October, A.D. 2022 Plan No.(dep 1218/2022) WLTO in SE 1/4 Sec. 25, Tp. 7, Range 3 EPM, be and the same is hereby closed.
 - 2) That all that portion of the municipal road so closed, excepting thereout all mines and minerals and other matters as reserved in the Crown Lands Act, shall be transferred to Sunset Estates Ltd. for consolidation with adjacent properties through subdivision file 4340-22-8729. The Chief Administrative Officer is authorized and directed to do all acts and execute all documents required for the transfer.

Private Well Water Testing

The Seine Rat Roseau Watershed District will be assisting residents with private well water testing. Water sample bottles and application forms can be picked up in advance at the Town Office (329 Bronstone Drive). Testing dates will

Thursday, June 22, and all samples must be taken and dropped off at the Town office <u>before 10 am</u> on these dates.

Payment of \$25 per sample must be included with the sample and only cash or cheque (made payable to Horizon Labs) will be accepted.

Compost Site Now Open

The Town Compost site, located at 736 Schultz Avenue, is now open for the 2023 season. Be sure to check the Town website (<u>whereyoubelong.ca</u>) for hours as they change over the season. However, **for the time being**, hours are as follows:

- Saturdays from 10 am to 4 pm
- Mondays from 2 pm to 8 pm
- Wednesdays from 2 pm to 8 pm



Please note that the site will only be accepting **grass clippings** and **leaves** at this time. Branches need to be brought to the local transfer station or a landfill site of your choosing–they will not be accepted at this site.

Please **<u>do not</u>** dump at the site until it is open. The site is under 24 hour surveillance.

With the weather getting nicer, there are more opportunities to take advantage of what the Town has to offer, including its various parks and amenities.



Hespeler Park, the largest park in Niverville at 91 acres, includes over 10 soccer pitches and 5 baseball diamonds, a splash pad, bike skills track, beach volleyball court, picnic shelter, outdoor exercise equipment, and a playground that represents Niverville's rich history.

Residents and visitors are free to explore what Niverville has to offer by using the many well-maintained walking paths including the self-guided history tour that lines Main Street. The Crow Wing Trail, connecting Winnipeg and Emerson, is part of the Trans Canada Trail and runs directly through the Town of Niverville. This trail will guide you through the wetlands pavilion area that was transformed from the Town's old lagoon to the beautiful wetlands, using a process called bioremediation. This section of Town is open for the public to explore while providing another great opportunity to enjoy what Manitoba nature has to offer.
