Minutes of the Public Hearing held on November 1, 2022 at 9:02 a.m. regarding the Public Hearing for Subdivision File #4340-22-8693, which proposes to create 55 lots from CT 3104377/1, dedicate 3 areas for public reserve and open/extend public roads in the Niverville Business Park (Phase 4). The proposal was duly advertised as per Section 169 of *The Planning Act*. Mayor Myron Dyck served as chairperson, with Councillors Chris Wiebe, Nathan Dueck, Bill Fast and Meghan Beasant in attendance.

CAO Eric King provided an overview of the subdivision proposal, noting this was for Phase 4 of the (Niverville) Business Park, and the proposal was to create 55 lots from remaining section of land, which includes dedicating 3 areas for public reserve and open/extending public roads in the Business Park. This will finish the Niverville Business Park.

There was no opposition to the subdivision proposal.

Councillor Wiebe asked whether we would be developing the whole park and the number of lots in Phase 4.

CAO Eric King responded that the Town may develop in multiple phases and the number of lots in Phase 4 would be 55.

Mayor Dyck commented that this was the layout of the rest of the land and we had sold out on the first phases.
