I understand that if I fail to do all that I have herein undertaken and the fire escapes the approved location, I may be responsible for all costs incurred by the Town of Niverville in fighting the fire, and any losses arising therefrom to public or private property.	
I understand that the Niverville Fire Chief or any Designated Employee may revoke or suspend the High Hazard Fireworks Display Permit upon giving such a notice and opportunity to appeal the revocation or suspension where the Fire Chief or Designated Employee believes the I have contravened any of the conditions of the Permit, the provisions of By-law 864-24, or any provision of the Manitoba Fire Code or where conditions make the permitted activity unsafe.	
Further, I agree to absolve the Town of Niverville, the Niverville Fire & Emergency Services, and any Designated Employee of any and all damages or civil litigation caused by or attributable to a high hazard fireworks display initiated.	
This Permit is non-transferable and is valid only for a High Hazard Fireworks Display at the above location on the above noted fireworks display date.

### High Hazard Fireworks Display Permit - Terms and Conditions

The person to whom the High Hazard Fireworks Display Permit has been issued shall implement and comply with the following:

- Retain the Permit at the site of the High Hazard Fireworks Display and produce such Permit upon request.
- Allow the Niverville Fire & Emergency Services employees to enter and inspect the premises for compliance with all appliable sections of By-law 864-24.
- Set off the display on the property for which authorization has been received
- Ensure there are no overhead wires, branches, or other obstructions within eight meters (25 feet) when setting up a display
- Make a fire base (e.g. mound of sand or earth) at least 100 feet away from the nearest building
- Keep a large metal container partly filled with water for disposal of fireworks
- Provide a pail of water or garden hose, attached to a water supply- to be made ready as a fire extinguisher
- Not allow any person under the age of 18 years to set off or participate in the actual firing
- Ensure no fireworks are held by hand and fired. (Only sparklers are designed and manufactured to be handheld)
- Read all manufacturer's instructions on all novelties
- Bury all novelties at least halfway down into the firing base (e.g. mound of sand or earth)
- Light the fireworks at arm's length, stand back, and keep your face away. Carefully light the fuse at its tip- it is preferable to use an "igniter stick"
- Read and follow all instructions on the fireworks and plan the firing order before beginning.

# If a firework doesn't go off, do not attempt to re-light it, and do not approach it for several minutes. Douse it with water and carefully place it in a suitable refuse container.

### **Restrictions:**

- No person may set off any fireworks in or into any building, doorway, automobile, or other place where such setting off might create a danger or nuisance to any person or property
- Do not light a fire if the wind velocity exceeds 32 km/hr (20 mph) or if the wind direction is unfavorable
- No person may use, allow, or set off fireworks in such a place or manner as might create danger or constitute a nuisance to any person or property
- No person may do, cause, or allow any unsafe act or omission at the time and place for the setting off of any fireworks.

### **Remember:**

- The display must be conducted in a manner consistent with all safety procedures and be held and continued only while all proper precautions are being observed, to keep spectators at a safe distance and to protect public and private property.
- The display must be under the conduct and supervision of at least one responsible person, who must be at least 18 years of age. Suitable fire extinguishing equipment must always be on hand.
- Store fireworks in a cool, dry, and ventilated place in a locked container away from children.
