Mayor Myron Dyck commented that we are in the middle of the busy season for things and that he had spent time with the Grade 9 students working on their presentations with respect to their unit in government and why we need the senate, etc. He extended an invitation for students to reach out if they were interested in participating in a junior councillor program and encouraged them that they are the next generation to lead this community.

Mayor Dyck advised that he had just returned from our Federal Municipal Conference in Ottawa, where he had various experiences such as listening to the speeches of various ministers, sharing common themes with other delegates, and touring the Waterridge district in Ottawa, a 310 acre decommissioned airforce space featuring a "Brownstone" concept housing project and seeing how they worked with different community groups such as habitat for humanity and veteran affairs. He also spent some time investigating the municipal grants that are available. Mayor Dyck noted that he met with our MP in his Ottawa office and found out that the shadow critic for the Infrastructure and Communities Minister is Leslyn Lewis, with the message being that Federal funding for the province needs to flow. He added that there are various municipalities in Manitoba including ours that need funding for various projects, such as the RSR and the direct stream. Mayor Dyck requested a meeting with newly appointed Minister Robertson, who is in charge of this fund and housing, and would be available to fly out to make this meeting possible.

Mayor Dyck stated that tonight he will be attending the Minister's dinner in Winnipeg, where he will have the opportunity to meet various ministers during the different meal courses, and the table he has been assigned to will feature the Minister of Health, the Minister of Infrastructure and the Minister of Municipal Affairs. He intends to extend invitations to visit our community and discuss various matters such as annexation, Bill 4, RSR funding, etc. In addition, he will be attending a Premier's breakfast this Friday, and noted that our communications team has been putting together a short video on the Town that we hope to use for promoting it.

Minutes of a Public Hearing held on June 3, 2025, at 9:02 a.m. regarding Conditional Use C15-25, an application from Prairie Roots Fitness Ltd. to allow an indoor participant recreation service that includes a gym and fitness classes on Lot 22, Plan 61759, civically known as Unit 1 of 746 Schultz Avenue. The proposal was duly advertised as per Section 169 of *The Planning Act*. Mayor Myron Dyck, served as chairperson, with Councillors Nathan Dueck, Bill Fast and Meghan Beasant in attendance.

CAO Eric King advised that this was an application from Prairie Roots Fitness Ltd., which is a Conditional Use to allow for an indoor participant recreation service that includes a gym and fitness classes in Unit 1 of 746 Schultz Avenue. Background: The Conditional Use is requested to allow Prairie Roots Fitness Ltd. to operate in Unit 1 of 746 Schultz Avenue. This facility will offer a space where participants can work out at their own pace or with a trainer and will also offer fitness classes to the public. There are no fixed seating spaces; the total floor space is 1,200 sq. ft. with an 8' x 8' washroom in one corner. The property owner has already provided a revised site plan to accommodate the new parking requirement associated with this proposed use. The admin recommendation is to approve the Conditional Use application as requested.

There was no opposition to the proposal.

The public hearing was closed at 9:03 a.m.
